





The registration process is fine, but communications can still be improved.

ACBSP 2022 Practical Exam Survey









The examination rooms seem to meet most people's expectations, but some dissatisfaction with them was also found and a computer malfunction was reported.





Time between stations seems to be OK, although some people could still have different expectations.




A vast majority of the candidates think the information given was exactly what they needed before the exam.



If you answered no to the previous question, what information was not provided prior to the examination?


As a retake candidate, I would have preferred detail feedback from examiner on what I failed previously. Feedback given was extremely vague

I still don't know which part of procedure I should improve in spinal trauma station; the uncertainty confuses me a lot




Opinions regarding the information available on the website are divided. There was also a comment suggesting to keep that information available the entire year, because it was only there for a limited period of time.






Most opinions are positive here, but a comment stated that it should "be more streamlined to what testing expectations are".

Traveling with flights being canceled



How could your practical exam experience have been better?

Suggested Improvements

Below is a summary of the key points.

- 1. It is important not only to provide all pertinent information, but also to do it using a wellplanned strategy to ensure its effectiveness in all available channels (online, website and in-person).
- 2. Physical and technical conditions of the examination rooms could be checked regularly, so no examinee would face difficulties with these factors.
- 3. The feedback provided after the examinations could be more specific, pointing at each examinee's mistakes. Telling them the major topics with errors is useful, but also knowing what they wrongly marked could help them further investigate and resolve those doubts they might have.
- 4. Radiography section could include more views for each case. That would be closer to the real cases they will face and surely helps to be certain when deciding the patient's diagnosis.
- 5. Candidates had additional stress about COVID and travel, but ABCSP can do little about those.
